- 'Aberdeen City council: Property sales investigation' a report by the Controller of Audit to the Accounts Commission under Section 102(1) of the Local Government (Scotland) Act 1973 was published in April 2008
- The accounts of Aberdeen City council were qualified because the auditor was unable to obtain sufficient appropriate audit evidence concerning the bank reconciliation at 31 March 2008 to confirm that all bank transactions had been properly recorded.

- There were no reports published during this period that made reference to the comparative performance of councils.
